Note : 1) Site should be fully cleared after execution for health certificate is necessary.
2) The contractor should provide safety measures for digging work.
3) It, the under ground utility services i.e. Water pipe line, cable, sewer line, storm water drain line etc. are damaged during the execution work, the cost will be recovered from the bills of the contractors.

4) Contractor will have to get the work insured from New India Insurance Co. Regional Office- 2 Udhav Building Dharmapeth, West High Court Road, Shankar Nagar, Nagpur or from any agency as directed by State Government from time to time. They should submit the receipt of premium paid, after issuance of work order / site allotment letter, failing which their bill will not be passed for payment.
