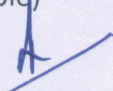

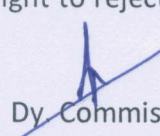

Terms & conditions for AMC of EPABX System

- 1) Rates should be inclusive of all Taxes (GST), levies & duties.
- 2) The rates should be for complete comprehensive maintenance contract of EPABX system. This includes free repairs and maintenance of all extensions, EPABX systems, float cum Boost charger, operator console and Battery maintenance. The Spares and accessories required to maintain complete system in working order should be replaced/repaired by contractor along with components cost in contract.
- 3) The service call should be attended within 6 hours from the lodging of complaint and should be rectified within 12 hours.
- 4) Successful contractor will have to execute an agreement as his cost on stamp paper of Rs. 500/-
- 5) NMC reserves the right to terminate the contract at any time, if the work of contractor found not up-to-the mark (i.e. unsatisfactorily) NMC may take action as deem fit against the contractor shall have no claim for the loss if happens to him due to such action.
- 6) Contractor will himself be responsible for statutory liabilities as per laws applicable for staff engaged by him, and NMC will not be responsible for any payment to workman or employees of contractor on any ground.
- 7) Contractor shall obtain registration if applicable under contract Labor act (Regulation and Abolition act 1970) and shall always be the "Principal" employer in relations to all the workmen employed by him for maintenance work.
- 8) If there is any loss of NMC property due to negligence of contractor's staff then whole responsibility will be of contractors and loss will be recovered from contractor. The work will be assessed for contractor's performance by NMC.
- 9) If the contractor fails to execute the work then NMC will terminate the contractor impose penalty, as per the law applicable.
- 10) The contractor will have to security deposit of 2% (Rounded to next Rs. 1000/-) of the quotation cost.
- 11) The penalty at the rate of Rs. 200/- per day shall be imposed if the complaint is not attended by the Contractor.
- 12) The penalty at the rate of Rs. 200/- per day shall be imposed if the complaint or fault not repaired within 24 hours by the Contractor.
- 13) If any dispute arises the decision of the Municipal Commissioner will be final binding on both the party.
- 14) Municipal Commissioner NMC, Nagpur reserves the right to reject any or all contractors without assigning any reason.
